The Ministry of Health & Family Welfare, Govt. of India has applied for a credit from the International Development Association (IDA) in the amount of US \$ 170 Million towards the cost of Second National Tuberculosis Control Project and it intends to apply the proceeds of this credit / grant to eligible payments under the proposed schedule for supply of goods for **Schedule I to X** under IDA funding
2. The RITES Ltd., on behalf of Ministry of Health & Family Welfare, Govt. of India now invites sealed bids from eligible bidders for the supply of Anti TB drugs. The Product code No., Product description, strength and unit pack alongwith required quantities are as follows.

3. Bidding will be conducted through the National Competitive Bidding procedures specified in the World Bank's *Guidelines: Procurement under IBRD Loans and IDA Credits* and is open to all bidders from eligible source countries as defined in the Guidelines.
4. Interested eligible bidders may obtain further information from and inspect the bidding documents at the address given below at S.No. 7 from 10 AM to 4 PM on any working day and before closing dates.

- a) Bidders are free to quote for any or all of the items listed in the Schedule of Requirements and the evaluation of bids will be conducted on a per-item basis. However, discounts offered by bidders for the award of a contract covering more than one item will be considered in the evaluation.
- b) Documentary evidence will be required of all bidders that they have the qualifications, experience and capacity to be able to successfully complete the contract on time for the pharmaceuticals and vaccines offered.
5. A complete set of bidding documents may be purchased from 26.06.2006 to 26.07.2006 by interested bidders on the submission of a written application to the General Manager (MSM) address below and upon payment of a nonrefundable fee *Rs 3000/-*. The method of payment will be a bank draft or certified banker's cheque made out in favour of the RITES Ltd. payable at Gurgaon. Bidding document requested by mail will be sent by courier or speed post on payment of an extra amount of *Rs.750/-*. Purchaser will not be held responsible for the postal delay, if any, in the delivery of the document or non receipt of the same.
6. Bids must be delivered to the address below at or before 11.00 am on 27.07.2006 . All bids must be accompanied by a bid security as specified in the bidding document. Late bids will be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 11:15 am on 27.07.2006 .
